We need to know well in advance who is seriously interested in signing up for camp this summer so that we can arrange to hire Conductors and staff members for each camp. Please understand that hiring the Conductors needs to be done months in advance for us to handle their visa requirements, flight, and hotel arrangements.

**You must also pay a non-refundable \$300 registration fee with your application** (this applies to both private pay and those using waivers) to secure your place in the summer camp. If this fee will place a financial burden on your family, please ask us about the family assistance fund.

Later in April, you will receive an invoice for the remaining balance due. You can choose to pay in full or make installments, but the entire balance will be due before the first day of camp. Don't forget that camp deposits and tuitions can be paid with your credit card online at [www.conductiveed.com](http://www.conductiveed.com). If a camp session is cancelled by CFCE for any reason, your application fee will be refunded. This is the only circumstance for which your application fee will be refunded.

### **Required: please mark the student's mobility level to ensure correct group placement\***

Low Mobility: Primary mobility aid is a wheelchair and/or supportive gait trainer. Working on floor mobility such as rolling and sitting up, short periods of weight bearing, and initiating stepping. Requires support for sitting.

Mid Mobility: Primary mobility aid is a wheelchair, walker, or canes. Can sit/stand independently or while holding onto something and take steps with or without a walker.

High Mobility: Independently mobile without aids such as a walker or canes. Can sit without physical support. May use mobility devices in the community, but primary mode of mobility is walking.

Life Skills Group: Walks independently but struggles with motor planning, complex movements (e.g. jumping, skipping), or coordination. Working on functional skills such as dressing, task follow-through, and social skills. Designed for those with a diagnosis of ASD, Down Syndrome, genetic conditions, etc.

**PLEASE READ:** The group is an important part of the method of Conductive Education. Therefore, if the student is the only one in their ability level signed up for a certain week, we may ask that you move to a different week.
